ORDINANCE NO. 12188-2011

AN ORDINANCE REVERTING THE SUM OF ₱100,000.00 FROM THE ITEM: MOOE-OFFICE SUPPLIES EXPENSES" IN THE 2011 ANNUAL BUDGET OF THE CITY GENERAL SERVICES OFFICE, THIS CITY, AND REAPPROPRIATING THE SAME TO BE MADE AVAILABLE TO AUGMENT THE ITEM "ADVERTISING, PROMOTIONAL AND MARKETING EXPENSES", OF SAID OFFICE

BE IT ORDAINED by the City Council (*Sangguniang Panlungsod*) of the City of Cagayan de Oro in session assembled that:
