AN ORDINANCE APPROVING THE APPLICATION OF THE COMMUNITIES CAGAYAN, INC. (CCI), REPRESENTED BY MS. CYNTHIA M. GALURA, BUSINESS DEVELOPMENT OFFICER, FOR THE CONSOLIDATION OF PLAN OF FRONTIERA II AND LA BRISA SUBDIVISIONS FROM 2,488 LOTS TO ONE (1) LOT, WITH AN AGGREGATE AREA OF 300,886 SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLES AND REGISTERED IN THE NAMES INDICATED IN THE HERETO ATTACHED MASTERLIST THEREOF, ALL LOCATED IN BARANGAY LUMBIA, THIS CITY
