ORDINANCE NO. 15010-2025

AN ORDINANCE APPROPRIATING THE SUM OF ₱336,033.36 FROM THE "CONTINUING APPROPRIATION, ANNUAL BUDGET CY 2022, NON-OFFICE: ECONOMIC SERVICES SECTOR-SPECIAL PURPOSE FUND-LAND ACQUISITION/EXPROPRIATION", TO BE MADE AVAILABLE FOR THE FULL PAYMENT OF THE CLAIM FOR JUST COMPENSATION INCLUDING DOCUMENTATION AND REGISTRATION EXPENSES OF LOT 3858-E-2-B-1, PSD-10-009522, COVERED UNDER TCT NO. (T-127055) 137-2024003808, OWNED BY MR. GERUNDIO ORALE, JR., WHICH WAS AFFECTED BY THE 5.00-METER WIDE ROAD WITH EXISTING 4.00-METER WIDE PCCP AND 1.00-METER DRAINAGE, LOCATED IN BARANGAY CARMEN, THIS CITY; AND AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN THE CORRESPONDING DEED OF ABSOLUTE SALE THEREOF

BE IT ORDAINED by the 20th City Council of Cagayan de Oro City in session duly assembled that:

SECTION 1. The sum of ₱336,033.36 is hereby appropriated from the "Continuing Appropriation, Annual Budget CY 2022, Non-Office: Economic Services Sector-Special Purpose Fund-Land Acquisition/Expropriation", to be made available for the full payment of the claim for just compensation including documentation and registration expenses of Lot 3858-E-2-B-1, Psd-10-009522, covered under TCT No. (T-127055) 137-2024003808, owned by Mr. Gerundio Orale, Jr., which was affected by the 5.00-meter wide road with existing 4.00-meter wide PCCP and 1.00-meter drainage, located in Barangay Carmen, this City.

SECTION 2. For this purpose, the Honorable City Mayor is hereby authorized to sign the corresponding Deed of Absolute Sale thereof.

SECTION 3. This Ordinance shall take effect upon its approval.
