ORDINANCE NO. 15003-2025

AN ORDINANCE APPROPRIATING THE SUM OF ₱406,592.50 FROM THE "CONTINUING APPROPRIATION, ANNUAL BUDGET FOR CY 2022, NON-OFFICE: ECONOMIC SERVICES SECTOR-SPECIAL PURPOSE FUND-LAND ACQUISITION/EXPROPRIATION", TO BE MADE AVAILABLE FOR THE FULL PAYMENT OF THE CLAIM FOR JUST COMPENSATION INCLUDING REGISTRATION AND DOCUMENTATION EXPENSES OF LOT NO. 637-B SUBD. PLAN, PSD-24078 OWNED BY BATANGAS LAND COMPANY, WHICH WAS AFFECTED BY THE EXISTING 8.00-METER MACAHAMBUS ROAD PROJECT, LOCATED IN BARANGAY NO. 16, THIS CITY, DUE TO THE RE-ASSESSMENT OF ITS PROPERTY PER APPRAISAL REPORT DATED SEPTEMBER 13, 2024

BE IT ORDAINED by the 20th City Council of Cagayan de Oro City in session duly assembled that:

SECTION 1. The sum of ₱406,592.50 is hereby appropriated from the "Continuing Appropriation, Annual Budget for CY 2022, Non-Office: Economic Services Sector-Special Purpose Fund-Land Acquisition/Expropriation", to be made available for the full payment of the claim for just compensation including registration and documentation expenses of Lot No. 637-B Subd. Plan, Psd-24078 owned by Batangas Land Company, which was affected by the existing 8.00-meter Macahambus Road project, located in Barangay No. 16, this City, due to the re-assessment of its property per Appraisal Report dated September 13, 2024, viz:
