ORDINANCE NO. 15006-2025

AN ORDINANCE EXTENDING THE DEADLINE OF THE PERIOD FOR THE RENEWAL OF BUSINESS LICENSES/PERMITS IN CAGAYAN DE ORO CITY FROM JANUARY 20, 2025 TO FEBRUARY 28, 2025

Whereas, the Local Government Code of 1991 fixes the deadline for the renewal of business licenses/permits on January 20 of every year;

Whereas, Section 56 of the Cagayan de Oro City Revenue Code of 2015 authorizes the Sanggunian, for a justifiable reason or cause, to extend the same without surcharges or penalties, for a period not exceeding six (6) months;

Whereas, the Cagayan de Oro Chamber of Commerce and Industry Foundation, Inc. (ORO CHAMBER) and the Misamis Oriental Filipino-Chinese Chamber of Commerce & Industry, Inc. (MFOCCII) in their joint letter to His Honor, City Mayor Rolando A. Uy dated 14 January 2025, requested for the extension of the said deadline to February 28, 2025 "due to continuing challenges faced by many enterprises, including economic recovery efforts and financials constraints;;

Whereas, with the favorable endorsement thereof by Honorable City Mayor Rolando A. Uy, this Council finds the request valid and meritorious;

NOW, THEREFORE:

BE IT ORDAINED by the 20th City Council of Cagayan de Oro City in session duly assembled that:

SECTION 1. The deadline of the period for the renewal of business licenses/permits in Cagayan de Oro City is hereby extended from "January 20, 2025" to "February 28, 2025".


SECTION 2. This Ordinance shall take effect upon its approval.
